

CONSTITUTION OF THE IRANIAN STUDENTS ASSOCIATION OF THE
UNIVERSITY OF ILLINOIS

Article I

Name: The name of this organization shall be "Iranian Students Association of the University of Illinois," hereinafter called the Association.

Article II

~~Purpose: The purpose of this organization shall be:~~

Section 1. To strengthen fraternal and national bonds among Iranian students of the University of Illinois.

Section 2. To promote friendly relations between the Iranian students and other students at the University of Illinois.

Section 3. To make Iranian culture better understood by others through arranging meetings, friendship hours, and conducting special Iranian festivities and celebrations.

Section 4. To provide guidance to new Iranian students in matters of housing, registration, employment, and other pertinent problems.

Article III

Membership:

Section 1. Active membership is available to students, visiting scholars, faculty who are nationals of Iran, and other students, visiting scholars, and faculty who are interested in the objectives, programs, and activities of the Association.

Section 2. The executive committee may recommend to the

Association honorary membership to students, visiting scholars and faculty who have demonstrated an interest in the Association.

Article IV

Officers: The Association shall have an executive committee of five officers. They are: President, Vice-president, Secretary, Treasurer, and Activity Chairman.

Every Iranian student attending University of Illinois shall be eligible to be an officer. The officers shall be elected for one year. An officer may be elected for any number of successive years as long as he is a student at the University of Illinois. The time of election shall be in October of each year.

In the event of resignation of the president, the Vice-president will succeed him in office. The vacancy in the office of the Vice-president caused by the resignation of the President, and any other vacancy in the executive offices, shall be filled by general elections.

Article V

Meetings: The Association shall have at least one general meeting during each semester.

The executive committee shall have at least one general meeting during each month. The executive committee shall have the authority to call for special general meetings.

Article VI

Finances: A minimum of \$2.00 (two dollars) per semester shall be paid to the treasurer by every member of the Association. Honorary members are not subject to the Association dues. The executive committee may accept help in any form from any source consistent with the purpose of the Association.

In case of dissolution of the Association, the funds shall be disbursed to the Iranian Students Association of the United States, P.O. 1900, New York I, New York.

Article VII

Faculty Advisor: Any faculty member who is an Iranian or has some interest in Iran can be named as the faculty advisor by the executive committee.

Article VIII

Amendments to the Constitution: The method of amending this constitution shall be as follows:

- (1) Any proposed amendments must be presented in writing to any one of the officers.
- (2) The executive committee shall thoroughly examine the proposed amendment and call for a special general meeting within two weeks, if an ordinary general meeting is not scheduled during that period.
- (3) A quorum, which shall be one-half of the members of the association must be present at the meeting. An affirmative vote by three-fourths of those present shall be necessary for the adoption of all amendments.

CODE OF BYLAWS

Article I

Duties of the Officers:

- Section A. The president shall be responsible for the general management of the activities of the Association in accordance with the provisions of the constitution.
- Section B The Vice-President shall succeed the President in case of his inability to perform the duties of his office, and shall assist him in the performance of these duties.
- Section C The Secretary shall handle and keep the record of all correspondences and shall take minutes of all meetings of the executive committee and the general assembly.
- Section D The Treasurer shall be responsible for all financial matters of the Association. All funds shall be deposited with the Students Activities Advisor's Office.

Article II

Duties of the Executive Committee: The executive committee of the Association shall:

- Section A carry out the purpose of the Association as specified in the Article II of the constitution.
- Section B make arrangements for holding general meetings, friendship hours, and Iranian festivities and celebrations.
- Section C supervise the collection of the funds as determined in Article III of the constitution.
- Section D outline the activities of the Association within the framework of the constitution for the semester.

Article III

Election of the Officers: All officers shall be elected by the members at the general assembly.

Article IV

Parliamentary Procedure: All meetings of the Association shall be in accordance with Robert's Rule of Order.

Article V

Amending the Bylaws: Amending the Bylaws shall be possible in the general meetings. A two third vote of the members present in the general meeting shall be necessary for adoption of the amendments

CONSTITUTION OF THE IRANIAN STUDENTS ASSOCIATION OF THE
UNIVERSITY OF ILLINOIS

Article 1

Name: The name of this organization shall be "Iranian students Association of the University of Illinois," hereinafter called the Association.

Article 11

Purpose: The purpose of this organization shall be:

- Section 1. To strengthen fraternal and national bonds among Iranian students of the University of Illinois.
- Section 2. To promote friendly relations between Iranian students and other students at the University of Illinois.
- Section 3. To make Iranian culture better understood by others through arranging meetings, friendship hours, and conducting special Iranian festivities and celebrations.
- Section 4. To provide guidance to new Iranian students in matters of housing, registration, employment, and other pertinent problems.

Article 111

Membership:

- Section 1. Active membership is available to students, visiting scholars, faculty who are nationals of Iran, and other students, visiting scholars, and faculty who are interested in the objectives, programs, and activities of the association.
- Section 2. The executive committee may recommend to the Association honorary membership to students, visiting scholars and faculty who have demonstrated an interest in the Association.

Article IV

Officers: The Association shall have an executive committee of five officers. They are: President, Vice-president, Secretary, Treasurer, and Activity Chairman.

Every Iranian student attending University of Illinois shall be eligible to be an officer. The officers shall be elected for one year. An officer may be elected for any number of successive years as long as he is a student at the University of Illinois. The time of election shall be in October of each year.

In the event of resignation of the president, the Vice-president will succeed him in office. The vacancy in the office of the Vice-president caused by the resignation of the President, and any other vacancy in the executive offices, shall be filled by general elections.

Article V

Meetings: The Association shall have at least one general meeting during each semester.

Article VI

Finances: A minimum of \$2 (two dollars) per semester shall be paid to the treasurer by every member of the Association. Honorary members are not subject to the Association dues. The executive committee may accept help in any form from any source consistent with the purpose of the Association.

In case of dissolution of the Association, the funds shall be disbursed to the Iranian Student Association of the United States, P. O. 1900, New York 1, New York.

Article VII

Faculty Adviser: Any faculty member who is an Iranian or has some interest in Iran can be named as the faculty adviser by the executive committee.

Article VIII

Amendments to the Constitution: The method of amending this constitution shall be as follows:

- (1) Any proposed amendments must be presented in writing to any one of the officers.
- (2) The executive committee shall thoroughly examine the proposed amendment and call for a special general meeting within two weeks, if an ordinary general meeting is not scheduled during that period.
- (3) A quorum, which shall be one-half of the members of the association, must be present at the meeting. An affirmative vote by three-fourths of those present shall be necessary for the adoption of all amendments.

CODE OF BYLAWS

Article 1

Duties of the Officers:

- Section A. The president shall be responsible for the general management of the activities of the Association in accordance with the provisions of the constitution.
- Section B. The Vice-President shall succeed the President in case of his inability to perform the duties of his office, and shall assist him in the performance of these duties.
- Section C. The Secretary shall handle and keep the record of all correspondences and shall take minutes of all meetings of the executive committee and the general assembly.
- Section D. The Treasurer shall be responsible for all financial matters of the Association. All funds shall be deposited with the Students Activities Advisor's Office.
- Section E. The Activity Chairman shall be responsible for all social activities of the Association.

Article 11

Duties of the Executive Committee: The executive of the association shall:

- Section A. Carry out the purpose of the Association as specified in Article 11 of the constitution.
- Section B. Make arrangements for holding general meetings, friendship hours, and Iranian festivities and celebrations.
- Section C. Supervise the collection of funds as determined in Article 111 of the constitution.
- Section D. Outline the activities of the Association within the framework of the constitution for the semester.

Article 111

Election of the Officers: All officers shall be elected by the members at the general

assembly.

Article IV

Preliminary Procedure: All meetings of the Association shall be in accordance with Robert's Rules of Order.

Article V

Amending the Bylaws: Amendments to the Bylaws shall be possible in the general meetings. A two-thirds vote of the members present in the general meeting shall be necessary for adoption of the amendments.

ARTICLE 1. Name: "Iranian Student Association At Champaign-Urbana" (ISACU).

ARTICLE 2. Purposes:

- a) To streng then fraternal ties and freindly relations among Iranian students, and between Iranian student and other students at the University Of Illinois.

- e) To protect group interest of Iranian students.


ARTICLE 3. Membership:

All Iranian students, faculty, visiting scholars, and their spouses shall be elligible for membership.

ARTICLE 4. Executive committee:

ISACU shall have an executive committee of three officers:

- a) President. The president shall be responsible



for general management and social activities of ISACU.

b) Secretary. The secretary shall be responsible for arranging meetings, handling correspondences, keeping records, and succeeding the president in case of his inability to perform his/her duties.

c) Treasurer. The treasurer shall be responsible for all financial matters of the ISACU.

The executive committee has collective responsibility to carry out the goals of ISACU.

Article 5. General assembly:

The general assembly shall be held in december to elect officers and plan the next year's program.

Article 6. Finance:

a) The general assembly shall decide about the minimum membership fee each year.

b) The executive committee may accept donations, or arrange fund-raising programs consistent with the purposes of the association.

c) In the case of dissolution, the funds shall be disbursed to the Iranian Student Association of the United States, P. O. Box 17066, Long Beach Ca., 90807.

Article 7. Faculty advisors:

Any faculty member who has some interest in Iran may be named as the faculty advisor by the executive committee.

Article 8. Affiliation:

The ISACU is affiliated to the Iranian Student
